### (Dice Roll Contest)

#### OFFICIAL RULES

---

**NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING CONTEST IS OPEN TO LEGAL RESIDENTS OF THE U.S. ONLY, WHO MEET THE ELIGIBILITY REQUIREMENTS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED.**

**Promotion Period:** Contest registration is scheduled to begin on **3/1/10 at 12:01am PST and end 12/10/10 at 11:59pm PST** (the "Registration Period"). The grand prize contest events are scheduled to occur once per month (March, 2010 - December, 2010) **at the Morongo Casino Resort & Spa in Cabazon, CA on the FOURTH FRIDAY of each month (except for December, 2010 when the contest event will be held on the THIRD FRIDAY.)** The contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

**Who May Enter:** Contest is open to legal U.S. residents, who are age 18 or older as of date of entry with a valid driver's license, except the following classes of persons who are not eligible to enter:

- a. Employees, officers, and directors of Morongo Casino Resort & Spa ("Sponsor"), Clear Channel Communications, Inc. ("Administrator"), each of their respective franchisees, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this contest (collectively, "Released Parties") and the members of the immediate families or households of any of the above, whether or not related. "Immediate family members" includes, for purposes of this contest, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grand children) and each of their respective spouses.
- b. Individuals who are unable or unwilling to be present to participate in the grand prize contest event.

All online entries must be fully complete for all required registration information. Any entry submitted with an invalid email address will be disqualified.

Any incomplete or illegible entries will be disqualified. Released Parties are not responsible for lost, late, misdirected, illegible, incomplete, invalid, unintelligible, damaged, or for entries submitted in a manner that is not expressly allowed under these rules, or for any entry not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections; all of which will be disqualified.

Each participant must submit an entry on his/her own behalf. Any entry submitted on behalf of another individual or using another person's email address or name will be disqualified and ineligible to claim any prize. No mechanically reproduced or automated entries permitted. Use of any automated system to participate is prohibited and will result in disqualification and all such entries will be deemed void.

In the event of a dispute as to any on-line registration, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and he/she must be eligible according to these Official Rules. The unauthorized email account holder is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries received become the property of the Sponsor and will not be returned.

**Any available opt-in opportunities are not required to enter the Contest, and checking the opt-in boxes will not improve your chances of winning. By participating and submitting an entry, contestant agrees that sponsors and participating parties are authorized to contact entrant via email, mail, phone or any other form of media to make contestant aware of information pertinent to the contest, and to distribute information regarding the Sponsor(s) featured products, special events or promotional offers, or purchase incentives. Contestants may opt-out of any further email communication at any time by simply replying REMOVE to any email message, or following the provided opt-out instructions.**

**Finalist Selection & Notification:** Each month a total of (50) finalists will be chosen from among those who entered as described above:

**1. Casino Morongo Entries:** (15) Finalists will be chosen from the Casino Morongo Winners Club membership. Winner's Club members will earn points all month long playing either slots or table games. Every 25 points a guest earns will award them with 1 entry form. The more points earned, the more entry tickets awarded. To be eligible for the monthly drawing for one of these 15 finalist spots, entrants must go to Casino Morongo on the day of each monthly dice roll (currently scheduled for the fourth Friday of the month) and play with their card to activate their drawing tickets. At the time of the promotion (15) guests/Winner's Club members will be called to participate in the dice roll event. Finalists will have until 9:00pm PST to report to the designated registration area for the opportunity to participate. Any finalist who does not report by 9:00pm PST after being called to participate in the dice roll event may be disqualified. The first (1<sup>st</sup>) day of each month will start a new entry cycle. Any tickets earned the previous month will not be carried into the next month.

**2. kfi640.com Entries:** (5) Finalists will be selected via random drawing from all entries received each month at kfi640.com by the entry deadline at 12:00pm PST on the THIRD FRIDAY of each month.

**3. Additional Clear Channel Radio Los Angeles Station websites:** (30) finalists will be randomly selected from the Clear Channel Radio Rewards Clubs members as follows: (5) entrants per station will be drawn at random from those who used their points to enter the on line raffle by 12:00pm PST on the THRID FRIDAY of each month.

Any selected finalist who does not meet the eligibility requirements, does not wish to participate in the grand prize contest, or who is unable or unwilling to attend the designated grand prize event will be disqualified. Any selected finalist who fails to respond within 48 hours of the initial attempted contact will be disqualified (*the "48 hour requirement" only applies to sections 2 and 3 under Finalist Selection and Notification above*). An alternate finalist will be randomly selected per the procedures outlined above, time permitting. Only the finalists selected and notified by sponsor will be eligible to participate. All other entrants are ineligible. Finalist selection and participation is non-transferable. **No other individual may participate on behalf of a selected finalist.** Decisions of judges in the selection of finalists, and all matters related to this contest are final.

Selected finalist(s) for each month must be present at Casino Morongo on the fourth Friday of that month. To participate in the grand prize contest, finalists **MUST** check-in at the contest registration table no later than 9:00pm PST. Any contestant who fails to appear by the required deadline will be disqualified, and will not receive any alternate contest attempts, prize substitution or compensation. Sponsor and Administrator reserve the right in its sole discretion to change the date, time or location of the grand prize contest. Finalists will be notified of any changes at the time of their selection and/or notification. **In the event a finalist fails to appear at the designated date, time and location for the grand prize contest, Sponsor and Administrator reserve the right, in their sole discretion to randomly select replacement finalists from anyone in attendance from the crowd on the day of the contest. Difficulties with getting to location to enter or participate in the contest are not the responsibility of Sponsor or Administrator.**

## **Grand Prize Contest:**

In order for a grand prize to be awarded, an eligible contestant must print and sign their full name on the first unoccupied line of the provided official contestant registration form prior to their dice roll attempt. **Each contestant will receive a maximum of one (1) dice roll attempt.** Upon registration, eligible contestants will draw a number at random that will determine their place in the order of the dice roll. Once the number has been drawn, the contestants place in the dice roll order shall be final. Each eligible contestant must roll all 7 dice provided by Sponsor and have each die come to rest with the predetermined winning side face up, on a single roll attempt. The winning symbols for this contest are: **M-O-R-O-N-G-O**.

### **Eligible dice roll attempt requirements**

- All dice roll attempts must occur in the presence of the contest administrators, and must be recorded on video tape in its entirety. Any dice roll attempt not in the presence of the contest administrator, or that is not video taped for any reason will be disqualified and is not eligible for the grand prize;
- Contestants will not be permitted to take any practice or warm-up tosses prior to their attempt. Once a die has been rolled, their attempt is considered to be started.
- **Each eligible contestant must roll all 7 dice all at one time.** Contestants may not attempt to change the outcome of any rolled die, by hitting the die with a subsequent roll attempt;
- All (7) dice must be rolled on each individual contest attempt. The winning outcome must occur during a single roll attempt ó i.e. contestants may not combine letters during multiple roll attempts. Each roll is its own unique contest attempt, and the (7) winning letters must all land face-up on a single roll.
- Each die must be tossed in a completely random manner that does not allow the contestant to ósetó or óslideó the dice, alter or influence the random outcome of the roll;
- Each die must be rolled a minimum of 2-feet in distance from the contestant, in order to prevent the contestant from altering, affecting, influencing, or enhancing the random outcome of any roll. The contest administrator will designate the demarcation line that each die must cross during the roll;
- All dice must come to rest lying flat;
- All dice must land on and remain on the designated dice rolling surface;
- No rolled die may come in contact with any person or object other than the designated rolling surfaces or walls.
- If any die comes in contact with another person or object (other than the dice roll surface or designated walls or backstop) for any reason; or if any person or object in any way interferes, alters, changes, influences or affects the random outcome of the roll, then the entire attempt is disqualified and the contestant may not receive another attempt.

### **The following will result in the contestant being required to re-roll their entire dice roll attempt:**

If any of the following outcomes occur, that dice roll attempt is disqualified and the contestant will be granted a maximum of one re-roll attempt (the contestant must re-roll all 7 dice):

- If the contest administrator deems that any die has failed to cross the dice roll demarcation line;
- If any die is leaning in any manner;
- If any die leaves the designated dice roll playing surface;
- If any contestant inadvertently drops a die as they are preparing to roll, and the dropped die does not meet the eligible dice roll requirements as stated in the contest rules.

In all circumstances, an eligible contestant may have a maximum of one re-roll attempt. In the event of a second ineligible dice roll, their entire dice roll attempt will be disqualified and the contestant will not be eligible for any prize claim regardless of the outcome of their roll.

## **Prize Awards & Delivery:**

### **Grand Prize ó In the event of a successful grand prize dice roll (M-O-R-O-N-G-O):**

In the event of a successful dice roll attempt by any eligible contestant, then the grand prize will be awarded subject to verification and compliance with these Official Rules. The grand prize is a **\$1,000,000 40-year annuity. If awarded, grand prize will be payable in (40) equal annual installments of \$25,000 Cash, without interest, on or about the anniversary date of the winning attempt.** The first installment will be awarded approximately 2 to 4 weeks following verification and approval of all required contest information.

A maximum (1) grand prize will be awarded per event date, based upon the first eligible contestant who successfully completes the grand prize dice roll contest requirements. The contest is immediately concluded following the first successful grand prize dice roll contest attempt, regardless of the number of finalists remaining for that event date who have not participated in their contest attempt. **In the event there is no eligible contestant who successfully completes the grand prize winning requirements according to these official rules, then the grand prize will not be awarded.**

Winner will be required to complete and return a W-9 form, affidavit of eligibility, and liability/publicity release, and present a valid driver's license and social security card before prize will be awarded. Winners of prizes greater than \$600.00 will be issued a 1099 form reflecting the value of the prize and are responsible for paying all income taxes on prize. Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize. By accepting prizes, winners agree to hold sponsor, and released parties (collectively "Releasees"), from any claims, losses, actions, or damages of any kind, whether actual, incidental or consequential, for injury (including but not limited to death), damages, losses or expenses arising out of or relating to entrant's participation in this contest, or the acceptance, possession or use/misuse of any prize, or participation in prize-related activities (including but not limited to travel related thereto), and to assume all liability in connection therewith.

Releasees shall not be liable to any winner, entrant or any other person for failure to supply the prize or any part thereof by reason of any acts of God, any actions, regulations, orders, or requests by any governmental entity, equipment failure, terrorist acts, war, fire, unusually severe weather, embargo, labor dispute or strike, labor or material shortage, transportation interruption of any kind, or any other cause beyond Releasees' sole control. **IN CASE OF DISPUTES:** By participating, each entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court within the State of New Jersey; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
